- (1) Across and under the Highway Bridge which crosses Shell Creek near Wekiwa, Oklahoma, in Section 5, Township 19 North, R.11 East, beginning at a point 5/1 feet Southwest of the Northeast corner of the bridge and at an angle of 110° 30' from the West end of the bridge around to the north to the pipe line as shown on Plat No.1, attached to said application.
- (2) Under and across the paved county highway to Keystone, Oklahoma, near Sand Springs, Oklahoma, at a point 1648 feet west of the Quarter Section Corner between Sections 11 and 14, Township 19 North, Range 11 East, and 33 feet south of the Section line between said Sections 11 and 14 as shown by Plat No.2, attached to said application.
- (3) Under and parallel to and in the highway at angles as shown on plat and described as follows: The pipe line enters the highway at a point 369 feet West of the Quarter Section corner of Sections 11 and 14. Township 19 North, Range 11 East and goes out at a point 1125 feet east of the Quarter Section Corner of Sections 11 and 14. Township North (19) Range 11 East, as shown on Plat No.3, of said application.
- (4) Under and across the highway between Sections 11 and 12, Township 19
 North Range 11 East, 40 feet North of the Section Corner of Sections 11, 12,13
 and 14, Township 19 North, Range 11 East, and a lead to Pierce's Refinery from
 the main line crosses the highway between Sections 12 and 13, Township 19 North
 Range 11 East, 100feet east of the section corner of Sections 11, 12, 13 and 14,
 Township 19 North, Range 11 East as shown on Map No.4, attached to said application.
- (5) Under and across the highway between Sections 1, Township 19, North, Range 11 East and Section 7, Township 19 North, Range 12, East at a point 104.4 feet North of the meander corner of the left bank of the Arkansas River for Sections 12, Township 19 North, Range 11 East and 7, Township 19, North, Range 12, East as shown on Plat #5 attached to said application.
- (6) Under and across the highway between Sections 7 and 8, Township 19 North Range 12 East at a point 4 feet South of the Quarter Corner between Sections 7 and 8, Township 19 North, Range 12, East at angles shown on Plat No.6, attached to said application.

for the purpose of furnishing Shell Creek Water to various oil refineries, industries manufacturing enterprises and individuals living and located in Tulsa County, Oklahoma coming on to be heard.

The Board finds that the Sand Springs Home is a corporation duly organized and existing under and by virtue of the laws of the State of Oklahoma, and ithat it is authorized by its Charter to furnish water to various inhabitants, factories, refineries and other industries within the County of Tulsa and the State of Oklahoma, and that the said Sand Springs Home has made contracts with various oil refineries and manufacturing enterprises and inhabitants located within the County of Tulsa to furnish the said water.

The Board further finds that it is necessary for the said Sand Springs Home in order to furnish the said water to the said refineries, factories and inhabitants of Tulsa County to lay, construct, build, and maintain and operate under across and through the public highways above described a thirty six inch pipe line at the points and places as above set forth.

IT IS THEREFORE ORDERED, that the said Sand Springs Home be, and is hereby authorized to and is granted the right to construct a thirty six inch pipe line under across and through the following public highways located in Tulsa County, State of Oklahoma, and at the following points, to-wit:

- (1) Under and across the Highway Bridge which crosses Shell Creek near Wekiwa, Oklahoma, in Section 5, Township 19 North, Range 11 East, beginning at a point 5.1 feet Southwest of the Northeast Corner of the Bridge and at an angle of 110° 30' from the West endoofhthe bridge around to the North oto the pipe line, as shown on Plat No.1, filed herein.
- (2) Under and across the paved county highway to Keystone, Oklahoma, near Sand Springs, Oklahoma, at a point 1648 feet west of the Quarter Section corner between Sections 11 and 14, Township 19 North, Range 11 East, and 33 feet South of the Section line between said Sections 11 and 14, as Shown on Plat No. 2, filed herein.
- (3) Under and parallel to and in the highway at angles as shown on plat and described as follows: The pipe line enters the highway at a point 369 feet West of the Quarter Section Corner of Sections 11 and 14, Township 19 North, Range 11 East and goes out at a point 1125 feet East of the Quarter Section Corner of Section 11 and 14, Township 19 North, Range 11 East as shown on Plat #3 filed herein.
- (4) Under and across the highway between Sections 11 and 12, Township 19 North, Range 11 East, 40 feet North of the Section corner of Sections 11, 12,13, and 14, Township 19 North, Range 11 East and a lead to Pierce's Refinery from the main line crosses the highway between Sections 12 and 13, Township 19 North Range 11 East 100 feet east of the Section corner of Sections 11,12,13 and 14, Township 19 North, Range 11 East, as shown on Map No. 4 filed herein.
- (5) Under and across the highwaynbetween Sections 1, Township 19 North Range 11 East, and Section 7 Township 19 North, Range 12 East, at a point 104.4 feet North of the meander corner of the left bank of the Arkansas River for Sections 12, Township 19 North, Range Eleven east and seven, township 19, North, Range 12 East as shown on Plat No.5, filed herein.
- (6) Under and across the highway between Sections 7 and 8, Township19 North, Range 12, East at a point 4 feet south of the Quarter corner between Sections 7 and 8, Township 19 North, Range 12 East at angles shown on Plat No.6, filed herein.
