At a meeting of the Board of County Commissioners of Tulsa County, State of Oklahoma, held on the 30th. day of March, 1925, the following communication was directed by said Board to be forwarded to the State Highway Commission of Oklahoma:

Hon. State Highway Commission,

Oklahoma City, Oklahoma.

Gentlemen:

The Board of County Commissioners of Tulsa County, having under the existence of a previous law, agreed with your Commission on the terms of co-operation in the construction of Four (4) Miles of Federal Aid Highway in this County, known and designated as Section "C", Federal Aid Project No. 111, now desires to withdraw the former understandings had with your Commission in respect thereto; this due for the reason that since such previous understanding the Legislature of Oklahoma has materially changed the laws respecting the raising of revenues, and under the circumstances it is felt that all previous understandings should be abrogated with respect to the above mentioned project and the matter in question be subject to consideration as coming under the provisions of the now existing laws.

R E S O L U T I O N.

WHEREAS, it appears from the records of the Court Clerk, and the files and records in the office of the County Attorney, that on the 18th. day of November 1921, the State of Oklahoma upon the relation of W F Seaver, the then duly elected, qualified and acting County Attorney of Tulsa County, filed an action in the office of said Court Clerk wherein the State of Oklahoma was Plaintiff and A H Keys, J H Rollerson, L Hollingsworth and L J Johnson were Defendants, said cause being District Court No. 17026, said action having been instituted for the purpose of enforcing the penalty of a certain appearance bond in the case of the State of Oklahoma vs A H Keys, and

WHEREAS, it further appears that thereafter in the progress of said cause, and to-wit: On the 14th. day of February, 1922, a judgment was, by consideration of the District Court, rendered and entered in favor of the State of Oklahoma, for the use and benefit of Tulsa County, and against said J H Rollerson, et al, for the sum of Five Thousand Dollars (\$5000.00) together with interest thereon, and for costs, and

WHEREAS, it further appears that a writ of execution issued out of the office of the Court Clerk upon said judgment, and levy made upon the real property herein-after described, as the property of J H Rollerson, and said real estate was duly advertised and sold under said execution, and was struck off at said sale to said W F Seaver, as Trustee, for the use and benefit of Tulsa County.
