and to do all things necessary to the successful construction and maintenance of said pipe lines across said public highways, said thirty six inch (36") pipe line to be constructed in a workmanlike manner and according to the plans and specifications submitted with the application of the said Sand Springs Home; the said Sand Springs Home to be liable for any negligent act or omission in the construction of said pipe line, and that said Sand Springs Home will hold the County harmless from any liability arising from any negligent act or omssion.

IT IS FURTHER ORDERED that the said Sand Springs Home shall at any time have the right to repair the said pipe line so constructed under and across the highways as above set forth.

RESOLUTION.

WHEREAS, in times past many additions to the City of Tulsa, and subdivisions of land have been mapped, platted and surveyed, and the plats thereof filed with the County and the said plats setting out the streets, and which streets as dedicated to the uses of the public have in many cases filed to conform to and in line with streets, etc., in adjacent additions to the City of Tulsa.

AND, WHEREAS, such practice is wrong and to the detriment of the spublic and is not consistent with the better practices which should prevail in order to build a city without more or less confusion in the naming and numbering of streets and boulevards, etc., and in the appearance thereof.

AND, WHEREAS, the City Planning Commission of the City of Tulsa, in their study of the present and future traffic needs have met with the obstacles above mentioned.

AND, WHEREAS, this Commission believing that the owners of property adjacent to the City of Tulsa desire to co-operate in every way possible with the said Planning Commission of the City of Tulsa and with this Commission.

BE IT THEREFORE RESOLVED: That each and every owner of lands now contemplating the platting thereof, or in the future contemplating the platting of the same, and each and every surveyor or engineer now engaged or who may be engaged to plat and survey townsite additions should and by right ought to co-operate to the extent that the said streets, boulevards, driveways, etc., be laid out to conform to adjacent streets, etc., and to co-operate in ever way well and reasonable with the City Planning Commisson and this Board in the interest of the future growth, commercial and general welfare of the City of Tulsa.
