

## O R D E R

WHEREAS, The Treasurer of Tulsa County, Oklahoma, has filed and presented to the Board of County Commissioners of the County of Tulsa, State of Oklahoma, an application for the issuance to FRED G GROSSHART of a deed conveying to him for a consideration of Five and 95/100 Dollars (\$5.95) the following lot:

Lot Sixteen (16) Block Five (5) New Taneha Addition

AND, WHEREAS, the sale of said lot by the County Treasurer was made pursuant to Section 9745 of the C O S of 1921, and amendments thereto, whereby the County Treasurer is authorized to sell lands and lots purchased for the County by him at tax re-sale and,

WHEREAS, due notice has been given and published by the County Treasurer in the Tulsa Daily Register the official paper of the County of Tulsa, that said County Treas. would on this date apply to the Board of County Commissioners for an order approving said sale, and directing the issuance of deed therefor, and

WHEREAS, pursuant to such notice, hearing on such sale has been had by the Board of County Commissioners, and no other persons having appeared to bid a higher price for the purchase of said lot, and the County of Tulsa has no need for said lot for any purpose required and provided by law whatsoever.

NOW, THEREFORE, The Board of County Commissioners of the County of Tulsa, State of Oklahoma, in regular session assembled and pursuant to the aforesaid statutes of the State of Oklahoma, hereby approve the sale of said property so made by the County Treas. to FRED G GROSSHART for a consideration of \$5.95 and it is hereby ordered that the Chairman of the Board of County Commissioners execute to FRED G GROSSHART a deed conveying to him all the right, title and interest of the County of Tulsa, State of Oklahoma, in and to said property, and the County Clerk of Tulsa County is hereby directed to attest with his signature and attach the seal of his office.
