WHEREAS, The Treasurer of Tulsa County, Oklahoma, has filed and presented to the Board of County Commissioners of the County of Tulsa, State of Oklahoma, an application for the issuance to A B ECHOLS of a deed conveying to him for a consideration of Ten and no/100 Dollars (\$10.00) the following described lot:

AND, WHEREAS, the sale of said lot by the County Treasurer was made pursuant to Section 9745 of the compiled Statutes of Oklahoma of 1921, and amendments thereof, whereby the County Treasurer is authorized to sell lands and lots purchased for the County by him at tax resale, and
