Gentlemen:

I, Joe T. Parkinson, the duly elected and qualified County Treasurer of Tulsa County, Oklahoma, hereby certify the total assessments, against all properties located in Drainage District No. 12, as shown by the Viewers' report filed in the office of the County Treasurer, to be the sum of \$210,553.76.

I further certify subsequent to filing said report there has been stricken from said assessment the sum of \$26.00 the same being an erroneous assessment against Lots 45, 46 and 47 of Block 1, Blue Ridge Addition, leaving the net assessment to be collected in said District the sum of \$210,527.76.

I further certify of the total assessment in said District in the sum of \$210,527.76 numerous property owners have paid assessments in full for the benefit of said District the total sum of \$125,238.01, leaving assessments to be paid in 10 equal installments the total sum of \$85,289.75.

I further certify of the total unpaid assessments in the sum of \$85,289.75, there are assessments against Municipal Corporations the sum of \$32,293.00 leaving a balance of \$52,996.75 to be collected from individual property owners in said District.

I further certify of the balance in the sum of \$52,996.75 an assessment of \$5,000.00 against the Oklahoma Natural Gas Company, a corporation, is contained in said Viewers' report under miscellaneous assessments and said Corporation contends said assessment is void and refuses to pay same, thereby leaving undisputed assessments to be collected from individual property owners in ten equal installments the sum of \$47,996.75.
