Motion by Commissioner Gray, seconded by Commissioner Morley, that the Tulsa Daily Legal News be the official paper for publishing the proceedings of the County Commissioners. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion by Commissioner Greer, seconded by Commissioner Morley, that the Cash Fund Estimate of Needs and Request for Appropriation for the Restricted County Highway Cash Fund in the amount of \$4,282.81, be and the same is hereby approved and the Chairman is hereby authorized to sign said request and submit it to the Excise Board for their consideration.

Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion by Commissioner Greer, seconded by Commissioner Morley, that the Cash Fund Estimate of Needs and Request for Appropriation for the County Highway Cash Fund in the amount of \$8,248.84, be and the same is hereby approved and the Chairman is hereby authorized to sign said request and submit it to the Excise Board for their consideration. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion by Commissioner Gray, seconded by Commissioner Greer, that the report filed by Cal Crum, Court Clerk, for the District Court Division, for the month of June, 1942, be and the same is hereby accepted and filed. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion by Commissioner Greer, seconded by Commissioner Morley, that the judgment in favor of Tulsa County on the \$300.00 bond in Case No. 35,355, in the District Court of Tulsa, Oklahoma, insofar as it affects Lot 26, Block 3, Liberty Add. to the City of Tulsa, Oklahoma, be released and discharged; that is, said property be released and discharged from said judgment lien, for the reason that said judgment is no longer an enforceable lien thereon. Upon roll call the all members voting in the affirmative, motion was by the Chairman declared carried. NOW, THEREFORE, by virtue of the foregoing, the undersigned Chairman of the Board of County Commissioners does hereby release the judgement lien in cause No. 35,355 in the District Court of Tulsa County, Oklahoma, in the case entitled "State, ex rel, Byron Kirkpatrick, County Attorney of Tulsa County, Oklahoma, vs. G.
