Motion was made By Mr.North, seconded by Mr.Dickey, that Mr.A.M.Welch, County Humane Agent, be and he is hereby empowered to dismiss from the service of the Humane Society Mr.S P Kenton and Miss Mabel Murrell at his own discretion. Mr.Welch is also hereby instructed to personally " Okeh" all claims which are presented to the Board of County Commissioners for payment. Motion carried.

The Depository Bond of the Exchange National Bank of Tulsa was examined, found sufficient and approved by the Board of County Commissioners in the amount of Two Hundred Thousand(\$200,000.00) Dollars with the Exchange Trust Company as Surety.
