NOTICE OF HEARING ON REPORT OF DRAINAGE COMMISSIONER
OF PARKVIEW DRAINAGE DISTRICT.

Notice is hereby given to all the land owners in the Parkview Drainage District, and to all other persons in any-wise interested:

That on the 15th day of June, 1942, there was filed with the Board of County Commissioners of Tulsa County, Oklahoma, a statement in writing by owners of lands in the Park View Drainage District that the ditches and drains in said District need to be repaired and cleaned out and asking that an estimate be made by the Drainage Commissioner for the amount of work necessary to clean out said ditches and drains, and the amount necessary to be expended and that acting upon said application, the Board of County Commissioners ordered J. M. Baker, Drainage Commissioner to examine said drains and ditches and report, under oath, the amount of work required to clean out said drains and ditches, together with an estimate of the amount of money which would necessarily be expended.

The said J. M. Baker has, on the 8th day of July, 1942, filed his report thereon, in which he estimates that it will be necessary to expend the sum of Eight Thousand Dollars (\$8,000.00) in repairing and cleaning out ditches and drains in the District, and the Board of County Commissioners have fixed the time and place of hearing on said report to be at 10 A.M., on the 24th day of August, 1942, in the office of the Board of County Commissioners of Tulsa County, Oklahoma, in the Tulsa County Court House in the City of Tulsa, Tulsa County, Oklahoma, at which time the report of said Drainage Commissioner will be passed upon and at which time it will be determined as to whether or not the sum of Eight Thousand Dollars, or any other sum, will be expended in repairing and cleaning out the drains and ditches in the Park View Drainage District, and at which time anyone interested may appear and be heard, for or against the report.
