R E S O L U T I O N

This matter coming on to be heard, this 12th day of January, 1948, before the Board of County Commissioners of Tulsa County, Oklahoma, upon the Application of Elmer W. Adams, County Attorney of Tulsa County, Oklahoma, for approval of a settlement of the bond forfeiture in the case of STATE OF OKLAHOMA vs. RUSSELL HAMPTON, being Case No. 52501 in the Court of Common Pleas of Tulsa County, Oklahoma; and the Board being fully advised in the premises finds:

That Russell Hampton was on the 12th day of August, 1947, released from custody under a bond of \$500.00, the sureties being Verna Boone and C. W. Boone. That on January 6, 1948, said bond was forfeited and suit ordered filed. That the sureties herein have this day offered \$400.00 in cash as full settlement of this bond forfeiture without suit being filed. The Board further finds that the County Attorney of Tulsa County recommends said settlement.

IT IS THEREFORE RESOLVED by the Board of County Commissioners: That said settlement should be approved in the sum of \$400.00 and that the County Attorney retain \$100.00, or 25%, for his fee, as is allowed by law, the balance of \$300.00 to be paid to the Court Clerk of Tulsa County, Oklahoma.
