RESOLUTION

RESOLUTION OF THE BOARD OF COUNTY
COMMISSIONERS OF TULSA COUNTY, State of
OKLAHOMA, APPOINTING REPRESENTATIVES
AS MEMBERS OF JOINT AIRPORT ZONING
BOARD AND AUTHORIZING THE CREATION
OF A JOINT AIRPORT ZONING BOARD WITH
THE POWERS AND DUTIES PRESCRIBED BY
LAW.

WHEREAS, under the terms and provisions of House Bill No. 359, Session Laws of 1945 of the Legislature of Oklahoma, the same constituting a part of Title 3 of the Oklahoma Statutes, Sections 101 to 115 thereof, and the same being known as the Airport Zoning Act, it is provided, among other things, that in order to prevent the creation or establishment of airport hazards, every political subdivision having an airport hazard area within the territorial limits may adopt and enforce regulations pertaining thereto; and it is therein further provided that when any airport is owned by a political subdivision the hazard area of which is in another political subdivision, the zoning regulations may be adopted by a joint board; and

WHEREAS, the City of Tulsa, Oklahoma, owns the Tulsa Municipal Airport, the hazard area appertaining to which is principally located in Tulsa County and outside the territorial limits of the City of Tulsa, Oklahoma; and

WHEREAS, there are a number of additional airports in the County of Tulsa, the hazard area of which is principally located in said county; and

WHEREAS, the Board of County Commissioners of Tulsa County, Oklahoma, deems it necessary in the interest of the public health, public safety and general welfare that a joint airport zoning board be appointed as provided by law and for the purposes set forth in said statute and with the powers and duties therein specified;
