RESOLUTION ESTABLISHING COUNTY HIGHWAY IN DAWSON TOWNSHIP OF TULSA COUNTY.

WHEREAS, Senate Bill No. 44, of the Extraordinary Session of the Ninth Oklahoma Legislature, among other things, provided for the designation of County Highways NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF COUNTY COMMISSIONERS, of Tulsa County, State of Oklahoma, that it is deemed to be to the best interests of the Tulsa County, and there is hereby established as a County Highway, the following, tentatively

and approximately described, subject to location, surveys hereafter to be made, viz:

"Beginning on a heratofore designated County Highway, on the south line of Section 16, Township 20 North, Range 13 East, and running thence Northeasterly from the beginning point to an intersection with the East line of said Section 16; thence North across an existing bridge and following thence North to a curve to the right, which location the refrom is to follow approximately near the south bank of Bird Creek through Sections 10,11 and 12 of same Township and Range, to approximately one-quarter of a mile West of the Tulsa-Owasso Paved Highway, from whence said road is to run on a generally East course to said Owasso-Tulsa Paved Highway"

and the County Engineer is directed to make a correct location survey and may proceed with the construction of the grading and drainage openings thereon.
