

MONDAY, JULY 8, 1946

Pursuant to recess heretofore taken, the Board of County Commissioners reconvened at the hour of 2:00 o'clock A. M. with the following members present: J. B. Gray, Chairman; Curtis Greer and Claude W. Bailey, Members. Andy Stokes, County Clerk.

J. B. Gray, Chairman presiding, the following business was transacted.

Motion made by Commissioner Greer, seconded by Commissioner Bailey, that the appointment of W. L. Reed, ^{as} Deputy Court Clerk, in the Court of Common Pleas, to take the place of W. C. Freiberg who resigned, at a salary of \$160.00 per month, effective July 1st, 1946, be and the same is hereby approved. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Greer, seconded by Commissioner Gray, that the affidavit of erroneous assessment filed and approved by Dan A. Rowe, County Assessor, in favor of D. F. Gager - personal tax for 1945 in the amount of \$2.23, be and the same is hereby approved, and the County Clerk is hereby instructed to issue certificate of error covering same. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Greer, seconded by Commissioner Gray, that the Bids on Project #2-C for improvement of Wekiwa Road from Euchee Creek to Shell Creek, a distance of 1.212 miles, submitted by Layman & Company in the amount of \$21,380.60, together with their certified check for \$1050.00 and Standard Paving Company in the amount of \$21,246.20 together with their certified check for \$1050.00, be turned over to the County Engineer for compilation and report. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Gray, seconded by Commissioner Greer, that the bids on Project #1-B for the improvement of 56th St. North, Lewis Ave. and 66th St. North, a distance of 2.829 miles, submitted by the Standard Paving Company in the amount of \$42,726.74, together with their certified check for \$2150.00 and bid by Layman & Company in the amount of \$42,259.90, together with their certified check for \$2150.00 be turned over to the County Engineer for compilation and report. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Gray, seconded by Commissioner Bailey, that the Bids submitted by Standard Paving Company in the total amount of \$535,605.00, together with a certified check in the amount of \$26,500.00; F. M. Stowell in the total amount of \$516,222.50 together with certified check amounting to \$26,000.00 and bid submitted by J. A. Rains, Contractor, Muskogee, Oklahoma, in the amount of \$489,222.20 together with a certified check for \$30,000.00, covering the construction of Jenks Highway Bridge and approaches, be and the same are hereby rejected. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.
