In the matter of the Petition of the Oklahoma Natural Gas Corporation, the following order was made:

NOW, on this the 6th. day of September, 1927, the matter of the Petition of Oklahoma Natural Gas Corporation for permission to lay a pipe line along, under and across certain highways in said County and State came up before the Board of County Commissioners of said County for hearing, and it appearing to the Board and each of the Commissioners thereof that it was just that the said Oklahoma Natural Gas Corporation be permitted to use as much of the highways as designated by plat filed by said corporation, and according to said description, which is as follows, to-wit:

Beginning at a point in the Southeast quarter of Section 23, and running thence East across the public highway and thence South to a point in the Northwest quarter of Section 25, all in Township 19 North, Range 13 East; thereby crossing the North and South Section line between Sections 23 and 24, Twp 19 N., Range 13 E., and crossing the East and West Section line between Sections 24 and 25, Twp 19 N., Rge. 13 E., said
