AUGUST 7th 1916.

The following bids were received for four (4) bridges to be constructed in Tulsa County as per plans and specifications.

The Canton Bridge Company being the lowest and best bidder it was moved that the contract be awarded them.

Bids were received for the construction of a two room unit school house for the colored school on block 16 in the city of Tulsa.

W.H.Fletcher & Co.being the lowest bidder, the motion was made that he be awarded the contract, his bond being filed and the contract being entered into and he was instructed to go to work as soon as bond was approved.

AUGUST 8th. (adjourned session)

The County Commissioners met in adjourned session Tuesday August 8th 1916, bids were received for the painting of the jail in the Court House, together with other painting to be done, the following bids were received.

H.I.Rickey, \$440.00 for all steel work, all paint $22\frac{1}{2}$ cents per yard. Plymouth Decorating Co. \$442.00 all steel work, and for all wall work $23\frac{1}{2}$ per Yd

H.I.Rickey being the lowest bidder for all work, a motion was made that he be awarded the contract and instructed to go to work as soon as bond was filed and approved. Motion prevailed.

In the matter of the petition of Mary J.Barton. Vs. City of Tulsa, Mary J.Barton, being present in person to represent her own interest and John R.Woodard.Asst City Attorney representing the city, after arguing the matter at length, the matter was taken under advisement.

In the matter of the town of West Tulsa, J.R. Woodard representing the city, after discussing the reserve B and C in West Tulsa, a meeting was arranged to meet again Wednesday August 9th at 9 A.M. After considering the petition of the city over the matter of Mary J.Barton and the petition of the City of West Tulsa, a motion was made that John T. Kramer and John L. Smiley, and F.M. Wooden be appointed as appraisers in the Mary J. Barton land in Section 20-12 and the County Clerk was instructed to notify said viewers to proceed with their appraising said streets across said ground. There were also appointed appraisers to apprinted apprisers to appriaise the road-way from the bridge to the Creek County line, said road to be a 50 ft. road from the south line of West Tulsa to the city limits of Red Fork, thence on the Couth side of the Frisco Right of Way, along said right of way, 50 foot road way to the Creek county line and made said report at their earliest possible date.

A motion was made that Fred Langley be appointed book-keeper in the Engineer's office at a salary of \$100.00 per month.

A motion passes to accept the proposition of J.M.Chandley, whereby Tulsa County is to abandon the present county road at the inter-section of 10 and 11 and 14 and 15 to the city himits of Red Fork and in connection therewith, Tulsa County is to receive \$4300.00 for said right of way. Motion carried.

The City of Tulsa, through their representative. J.R.Wooden city attorney, and John H Simmons. Mayor, made the County Commissioners a proposition, that they help purchase and condemn a road way through the town of West Tulsa, along reserve B & C to Mitchell Avenue, said city of Tulsa agreeing to pave or construct a hard surface road from the new bridge to the south limits of West Tulsa. The Co mmissioners agreeing thereof, to construct a good road from the South limits of West Tulsa to the North limits of Red Fork.

An order was made that all road supervisors must make a report to the County Clerk at the end of each month and shall deposit all money collected from the collection of poll tax with the county Treasurer and to file his receipts with the County Clerk, for all money collected, and the County Clerk was instructed to notify all road supervisors.

After considering the petiton of C.C.Spillman, Justice of the Peace of Sand Springs. It was moved and seconded that C.C.Spillman be appointed Justice of the Peace to the town of Sand Springs, and same being confirmed, bond was filed.

A bid of Lon R.Stansberry for 25 feet of lot 5 in block 149 for \$6;000.00 belonging to Tulsa County was rejected, it being the opinion of the Commissioners that the money bid was unsifficient.

A motion was made that L.L. Huntsman, workman on the county farm, be notified that after September 1st 1916, his services would no longer be needed.
