In the matter of the application of the Leavell Coal Company for Permission to carry on Coal Mining operations across certain Highways of Tulsa County, Oklahoma.

ORDER.

Now on this 21st day of June, 1920, comes on for hearing the application off the Leavell Coal Company for permission to build a spur track on Section Twenty Eight (28), Township Twenty (20) North, Range Thirteen (13) East, across the highway north of and adjacent to the St. Louis and San Francisco Railroad right0of-way, and for permission to carry on its coal mining operatons across sections lines between sections twenty Seven and Twenty Eight (27 & 28) in said Township twenty (20) north, Range Thirteen (13) East, and between sections twenty two (22) and twenty seven (27) in said Township twenty (20) north, Range Thirteen (13) East, and the commissioners having heard evidence and being fully advised in the premises, find that the said petition should be granted upon the terms hereinafter expressed.

It is therefore ordered by the Commissioners that the Leavell Coal Company, a corporation, organized and existing under the laws of the State of Oklahoma, ot the St. Louis and San Francisco Railroad Company on its behalf, be, and it is hereby, granted the right and privilege to lay and maintain a spur track across the public highway thirty three (33) feet wide adjacent to and paralleling the St. Louis and San Francisco Railroad right@of-way on the north side thereof, in Section twenty eight (28), Township twenty (20) north Range Thirteen (13) east, Tulsa County, Oklahoma, said spur track to be laid and maintained across said right@of-way at the place indicated in the plat attacked to the petition of the Leavell Coal Company, for a period of ten (10) years from the date of this order, said spur track to be both installed and maintained in such manner as not to interfere with traffic along said right-of-way.

It is further ordered that the Leavell Coal Company betpermitted to cross and recross with its stripping operations in carrying on its coal mining business the section line between Sections twenty seven (27) and twenty eight (28) and between Sections Twenty Seven (27) and twenty two (22) all in Township Twenty North (20), range thirteen (13) East, provided that before the said Leavell Coal Company may exercise its privilege hereby granted, it shall open up a public road, as indicated in its petition filed herein.
