Pursuant to recess heretofore taken, the Board of County Commissioners reconvened at the hour of 2:00 o'clock P. M. with the following members present. J. B. Gray, Chairman; Curtis Greer and Claude W. Bailey, Members. Andy Stokes, County Clerk.

J. B. Gray, Chairman presiding, the following business was transacted.

Motion made by Commissioner Greer, seconded by Commissioner Bailey, that Maintenance and Operation Budget for Tulsa County Drainage District No. 12, for the Fiscal year 1946-1947, as filed by Richard Erwin, Commissioner for the Drainage District, in the amount of \$52,500.00, be and the same is hereby approved. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Gray, seconded by Commissioner Bailey, that the Bond filed by W. L. Reed in the amount of \$1,000 and made by the Ohio Casualty Insurance Company, be and the same is hereby approved. Mr. Reed is a Deputy Court Clerk, in the Court of Common Pleas. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Gray, seconded by Commissioner Greer, that a recess be taken until 4:00 o'clock P. M. Motion carried.

ORDER DECLARING THE INCORPORATION OF THE  
TOWN OF HIGHLAND PARK, TULSA COUNTY,  
OKLAHOMA

Now on this 10th day of July, 1946, the Board of County Commissioners of Tulsa County, State of Oklahoma, being in regular session, with all members present, take up for consideration the verified statement and return of the election inspectors who conducted the election on July 8, 1946, for the incorporation of the Town of Highland Park, Tulsa County, State of Oklahoma, and the Board having duly examined said statement and return of election, and having examined all other proceedings had in connection with the incorporation of said town of Highland Park, and being satisfied of the legality of all of said proceedings and of said election, find that said Town of Highland Park has been duly incorporated in accordance with the provisions of the laws of the State of Oklahoma, in such cases made and provided; that the territory embraced within said incorporated Town of Highland Park is all of Section 22, Township 19 North, Range 13 East, Tulsa County, State of Oklahoma, and said Board of County Commissioners concludes that said described territory has been and is now duly incorporated as
