The Board of County Commissioners met in adjourned regular session with all members present: W W Stuckey, Chairman, W L North and Ed W Hedgecock, members. O G Weaver, County Clerk. The reading of the minutes of the previous meeting was dispensed with and there being no objections to the same they were ordered to stand approved.

In the matter of the establishment of a Drainage District on the Banks of the Arkansas River between the Towns of Sand Springs and Tulsa. After lengthy discussions on the part of protestants, the matter was placed in the hands of the Commissioners and upon motion of Mr. North, seconded by Mr. Hedgecock, the original petition of Ross, et al was rejected and the protests are hereby sustained.
