

SATURDAY, JANUARY 31, 1948

Pursuant to recess heretofore taken, the Board of County Commissioners met at the hour of 10:00 O'clock A. M., with all members present: Roy Evans, Chairman; Claude W. Bailey and John Couch, Members. William P. Gable, Jr., County Clerk.

Roy Evans, Chairman, presiding, the following official business was transacted:

Motion made by Commissioner Evans, seconded by Commissioner Bailey, and unanimously carried, that the Chairman be, and he is hereby authorized to execute a corrected County Commissioner's Resale Tax Deed covering Lot 14, Block 4, Bellevue Heights Addition. The original incorrected Deed read "Bellevue Addition".

Motion made by Commissioner Bailey, and seconded by Commissioner Couch, that the following Resolution be adopted:

R E S O L U T I O N

WHEREAS, Tulsa County is indebted to L. E. Howard in the amount of \$600.00, with interest at 6% per annum, from April 23, 1947, and court costs in the amount of \$4.70, by virtue of a judgment rendered in the Court of Common Pleas of Tulsa County, Oklahoma, in Cause No. 30846 Civil in said court;

AND WHEREAS, Tulsa County is indebted to the Guaranty Abstract Company in the amount of \$681.80, with interest at 6% per annum from June 20, 1947, and court costs in the amount of \$12.10, by virtue of a judgment rendered in the Court of Common Pleas of Tulsa County, Oklahoma, in Cause No. 31084 Civil in said court;

AND WHEREAS, an amount equivalent to one-third of each of said judgments has by the County Treasurer heretofore been paid to the Clerk of said Court of Common Pleas upon claims filed, as provided by Title 62, Section 365.5, O.S. Supp. 1947;

AND WHEREAS, the County Treasurer has canvassed his sinking fund and has ascertained that there is in the County Sinking Fund an amount of actual cash over and above the amount of cash needed to pay all coupons and bonds maturing and matured within the time such sinking fund will be replenished from revenues made or to be made for such judgment;

AND WHEREAS, the County Treasurer has requested the approval by this Board of his payment to the Clerk of said Court of Common Pleas of the balance due on each of said judgments, as provided by said Section 365.5, Title 62, O. S. Supp. 1947, and investment of County Sinking Funds in said judgments as provided by Section 541, Title 62, O. S. 1941; and

WHEREAS, each of said judgment creditors has as to each of said judgments, made an assignment to the said County Treasurer of the balance so due them

NOW THEREFORE, BE IT RESOLVED: That the County Treasurer of Tulsa County, Oklahoma, be, and he is hereby, authorized to invest the County Sinking Fund in said judgments, and upon claims filed by the Clerk of the Court of Common Pleas of Tulsa County, Oklahoma, to pay to said clerk, the balance of judgment due in said Cause No. 30846 Civil, in the amount of \$403.17, for the use and benefit of judgment creditor L. E. Howard or his assigns; and the balance of judgment due in said Cause No. 31084 Civil, in the amount of \$462.60, for the use and benefit of judgment creditor Guaranty Abstract Company or its assigns.
