"February 6, 1912.

Board of County Commissioners, Tulsa, Oklahoma. Gentlemen:-

For your \$666,000.00 road bonds, consisting of \$500,000.00 bonds of RoadDist. No. 1, and \$166,000.00 Tulsa County Road Bonds, bearing interest at 5% per annum, payable semi-annually in N.Y., delivered at such place as I may designate, I will pay par and interest, you to make an allowance of 3% to cover attorney fees and expenses in connection with the issue.

The foregoing proposal is subject to your furnishing me with a complete transcript of proceedings to show the legality and regularity of the issue to the satisfaction of my attorneys. If their opinion is unfavorable, it is agreed that you shall pay one-fourth of the usual fee of \$600.00, making \$150.00 to be paid by you if found illegal. I agree to furnish the preliminary opinion by February 16th, 1912.

In the event said opinion is favorable, I agree to take said bonds as soon as bond blanks can be prepared and executed. If unfavorable, I agree to assist and conduct one side of the necessary suit to secure the decision of the Supreme Court, or to furnish the proceedings for a new election and to take the bonds conditioned only on the favorable action of the Supreme Court, or of the voters, if resubmitted.

Viewers Road Dawson Township.

State of Oklahoma, Tulsa County.

In the matter of the Road Petition of Dawson Township, et al. To the Board of County Commissioners of said County:

We, the undersigned Viewers, appointed in the above entitled matter, respectfully report, that on the 2nd day of February, 1912, we met the County Surveyor of said County at the beginning point of said road described in said petition and viewed and caused said road to be surveyed and laid out upon and along the following line, to-wit:

Beginning at the north end of Bridge No. 140 upon Range line between T. 20 N. Range 13 and 14 E. an additional roadway of 81 feet upon each side to the Township line, thence east an additional 16.5 feet upon the north side of said highway east to section line between Sections 36 and 31, T.21 N. R. 13 and 14 East, Ind. Mer., and as shown by the plat and survey thereof returned herein by said County Surveyor.

We further report that said road is of public utility and that public convenience requires that said road be made 49.5 feet in width. We therefore recommend that said road be established for reasons above stated.
