O R D E R.

WHEREAS, The Treasurer of Tulsa County, Oklahoma, has filed and presented to the Board of County Commissioners of the County of Tulsa, State of Oklahoma, an application for the issuance to C H PAYNE the record owner of the lot hereinafter described, of a deed conveying to him for a consideration of Twenty and 52/100 (\$20.52) the following described lot, to-wit:
