In the matter of the Petition of Oklahoma Natural Gas Corporation for permission to lay a pipe line, the follingwng Order was made:

O R D E R.

NOW, on this the 3rd. day of March, 1930, the matter of the petition of Oklahoma Natural Gas Corporation for permission to lay a pipe line along, under and across ascertain highways in saidnCounty and State came up before the Board of County Commissioners of said County for hearing, and it appearing to the Board and each of the Commissioners thereof, that it was just that the said Oklahoma Natural Gas Corporation be permitted to use as much of the highways as designated by plat filed by said corporation, and according to said description, which is as follows, to-wit:

Beginning at a point near the Northeast corner of the Northeast Quarter NE $\frac{1}{4}$ of Section 11, Township 19 North, Range 14 East, and extending to a point near the Southeast corner of the Northeast Quarter (NE $\frac{1}{4}$ of Section 11, Township 18 North, Range 14 East, paralleling North and South Section line highway between the NE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 11, and the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 12, for a distance of approximately thirty-five (35) rods, and crossing East and West Section line roads between Sections 11, 14, 23, 26 and 35, all in Township 19 North, Range 14 East, Section line road between Section 35, Township 19 North, Range 14 East, and Section 2, Township 18 North, Range 14, East, and Section line road between Sections 2 and 11, Township 18 North, Range 14 East, a six (6) inch gas pipe line located according to the blue print hereto attached and made a part hereof. Known as Line C-M-38 Extension.

Also, beginning at a point near the Southeast corner of the Southeast Quarter (SE $\frac{1}{4}$) of Section 23, extending to a point within the Southeast Quarter (SE $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) of Section 24, and crossing North and South section line highway between Sections 23 and 24, all in Township 19 North, Range 14 East, a two (2) inch gas pipe line located according to blue print hereto attached and made a part hereof. Known as Line C-W (Cornelius Bell #1) Extension.

AND, it further appearing from the petition herein that said pipe line will be so constructed as not to interfere with any of the rights of the general public in the use of said highway and will be constructed in accordance with all rules of the county Commissioners and the laws of the State of Oklahoma governing same.

IT IS HEREBY ORDERED AND ADJUDGED by the Board of County Commissioners of said County that permission be granted and the same is hereby granted to Oklahoma Natural Gas Corporation, its successors and assigns, to use as much of the highways as above designated.
