PERMIT TO ATTACH EIECTRIC EQUIPMENT TO BUILDING.

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, County of Tulsa, (hereinafter known as Grantor) being the owner of Lot Four (4) and South Fifty Feet of Lot Five (S50! L 5) in Block One Hundred Forty Nine (149), of the Original Town of Tulsa, Oklahoma, and the building located thereon, in consideration of the sum of One Dollar paid by the Public Service Company of Oklahoma (hereinafter called the Company) receipt of which is hereby acknowledged, and in further consideration of the enhanced value which will attach to said property by reason of the better appearance and greater freedom from obstruction in the rear of said building, does hereby grant to the Company a perpetual permit to attach, maintain, repair and replace steel brackets on the alley side of said building in accordance with attached blue print drawing, said brackets to be used for the support of cross arms or timbers carryingelectric wires and equipment through and over and along said alley.

It is understood and agreed that in the event the grantor, his successors, or assigns, desires to make alterations or extensions to said building which will necessitate the removal of said brackets, that the Company shall, upon thirty days notice, remove said brackets.
