Pursuant to a recess heretofore taken, the Board of County Commissioners reconvened at the hour of 10:00 o'clock a. m. today, with the following members present: John Couch, Chairman, Claude W. Bailey, Member and Andy Stokes, County Clerk. J. W. Hardesty, Member, absent.

John Couch, Chairman, presiding, the following business was transacted.

Motion made by Commissioner Bailey, seconded by Commissioner Couch, and unanimously carried, that the Cash Fund Estimate of Needs and Request for Appropriation for the Highway SU Restricted Cash Fund in the amount of \$7,295.44, and the Cash Fund Estimate of Needs and Request for Appropriations for the Highway ST Unrestricted Cash Fund in the amount of \$23,887.99, be and the same are hereby approved, and the Chairman is hereby authorized to sign same and submit to the Excise Board for approval.

Motion made by Commissioner Couch, seconded by Commissioner Bailey, that the following Resolution be and the same is hereby adopted, to-wit:

WHEREAS, the Highway Department is in need of a Ford Pick-up truck and was found that Fred Jones, Ford Dealer, has a new 1949 Ford F-1 One half ton 114" Pick-up, Motor No. 97HC-258177, that can be purchased for One thousand Five Hundred one dollars and forty three cents.

NOW, THEREFORE, BE IT RESOLVED, that the Chairman of the Board of County Commissioners be authorized to purchase said Ford Pick-Up, and the County Highway Department be authorized to draw a claim to Fred Jones, Ford Dealer, in the sum of One Thousand Five Hundred one dollars and forty three cents, payable from Account 6-B designated as Highway Equipment of the County Highway Department General Fund.
