"Now on this 16th day of February, 1912, the application of the Sands Springs Gas Company coming on for hearing for leave to lay pipe lines in, along and across highways and roads in the County of Tulsa, and the Commissioners in due session being advised in the premises, doth grant the order, and say, that the Sands Springs Gas Company is hereby granted leave to use and occupy the highways and roads of Tulsa County for the laying and maintaining of pipe lines for the conveying of gas to its plant at Sands Springs, Oklahoma, and over, under, across and through the highways and public roads of Tulsa County for delivery of gas to its customers; such pipe lines to be laid within three (3) feet of the outer boundary of the public road or highway so used, and to correspond with the grade of the highways and roads and so as not to interfere with the ordinary use thereof, the laying and maintaining of said pipe lines to be under the supervision and subject to the direction of the County Commissioners, and at the expense of the said Sand Springs Gas Company."

On this 16th day of February, 1912, there being presented to the Board of County Commissioners of Tulsa County, at its regular session in the City of Tulsa, Tulsa County, Oklahoma, a due and legal petition, signed by R. M. Brown, and eleven others, freeholders in said County, residing in the vicinity of the roads therein described, which said petition prays for the vacation of certain public roads between sections fourteen (14) and fifteen (15), township nineteen (19) north, range twelve (12) east, and in section fourteen, and in the Northeast quarter of the Northeast Quarter of section Twenty-two (22), township nineteen (19) north, range twelve (12) east, Tulsa County, State of Oklahoma; and for the opening and laying out of other roads in lieu thereof; and it appearing that proper bond has been filed with good and sufficient sureties, as provided by law, for the payment of all costs and
