RESOLUTION APPOINTING TAX FERRET

WHEREAS, the statutes of Oklahoma authorize the Board of County Commissioners of any County to contract with any person to assist the proper officials of the County in discovering, listing and assessing of property omitted and not assessed as required by law:

WHEREAS, it is the opinion of the Board of County Commissioners of Tulsa County, Oklahoma, that the necessity exists for the appointment of a person for the purpose contemplated by the statutes:

AND, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Tulsa County, Oklahoma, in regular meeting assemble that the Board of County Commissioners hereby employ and contract with C. E. Marshall to assist the proper officials of Tulsa County, Oklahoma, in the discovery and listing and assessment of property omitted from the tax rolls and not assessed as required by law, in accordance with the provisions of Section 12346 to 12350, inclusive, Oklahoma Statutes, 1931, and any and all other statutes of the State of Oklahoma, covering the subject matter of this resolution, and the employ of tax ferret and his duties pertaining to such employment.

. BE IT FURTHER RESOLVED, that this contract be and remain in force for a period of two years from the date hereof, and as long thereafter as may be mutually agreed upon between the Board of County Commissioners of Tulsa County and the said C. E. Marshall.
