NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF TULSA COUNTY, OKLAHOMA, AS FOLLOWS:

Section 1. That the United States of America be and it is hereby granted the right to close, destroy, alter and appropriate the following described county highway in Tulsa County, Oklahoma:

"Beginning at the West (W) line of Highway Seventy-Five (75) where said line intersects the section line between Sections Twenty-Four (24) and Twenty-Five (25), thence West (W) a distance of One (1) mile, Four Hundred Ninety-Five (495) Feet to a point Four Hundred Ninety-Five (495) Feet West (W) of the intersection of the above described East (E) and West (W) section line by the North (N) and South (S) Section line between Twenty-Five (25) and Twenty-Six (26), all in Township Twenty (20) North, Range Thirteen (13) East, Tulsa County, Oklahoma,"

for the purpose of constructing, developing, operating and maintaining an airplane bomber assembly plant, together with all accessory buildings, construction, aprons and runways in connection therewith as a military and National Defense project; and said roadway is hereby declared vacated and closed; provided, that this grant as to the following described land, to-wit:

"The Four Hundfed Ninety-Five (495) Feet West (W) of the interesection of the East (E) and West (W) section line by the North (N) and South (S) Section line between Sections Twenty-Five (25) and Twenty-Six (26), all in Township Twenty (20) North, Range Thirteen (13) East, Tulsa County, Oklahoma,"

shall not be and become effective unless and until the title to Lots Eighteen (18), Nineteen (19), and Twenty (20), Aerial Heights, an Addition in Tulsa County, Oklahoma, are secured from the present owners for National Defense purposes, in which event this grant shall in all things be in full force and effect to the entire roadway first hereinabove described.

Section 2. That the United States of America be and it is hereby granted the right to go into and take immediate, exclusive and permanent possession of the above described county highway for the uses and purposes above set out.

Section 3. That an emergency exists for the preservation of the public peace, health, safety, by reason whereof this Resolution shall take effect from and after its passage and approval.
