FRIDAY, JUNE 23rd, 1939.

Pursuant to recess heretofore taken, the Board of County Commissioners re-convened at the hour of 10:00 o'clock A.M., with the following members present: John H. Miller, Chairman; J. B. Gray, Member. Andy Stokes, County Clerk. Harry L. Hopkins, member, absent.

John H. Miller, Chairman presiding, the following business was transacted.

Reading of the minutes of the previous meeting was dispensed with and there being no objection to the same they were ordered to stand approved.

Motion by Commissioner Gray, seconded by Commissioner Hopkins, that the appointment of A. L. Carmichael as an extra in the office of the County Clerk at a salary of \$150.00 per month, be and the same is hereby confirmed as of June 21st, 1939. Motion carried.

John H. Miller, Chairman, deposited with the County Treasurer \$100.00 on June 22nd, 1939, collected from the Municipal Hospital. Receipt #18813. Same was ordered filed.

John H. Miller, Chairman, deposited on June 22nd, 1939, with the County Treasurer \$12.00 collected from Mrs. Guinn for water and gas in connection with the lunch counter. Receipt #18814. Same was ordered filed.

Motion by Commissioner Miller, seconded by Commissioner Gray, that W. E. Davis, County Engineer, be given authority to employ R. E. Nichols for the week from June 19th to June 24th, 1939, with authority to place him on the regular payroll at the rate of \$185.00 per month. Motion carried.

Motion by Commissioner Gray, seconded by Commissioner Miller, that Bill Allison (with tractor) be employed in the highway department as of May 20th up to and including May 31st, 1939, @ \$7.00 per day. Motion carried

Motion by Commissioner Gray, seconded by Commissioner Miller, that the following "Authority to Release Securities", be and the same is hereby approved and signed. Motion carried.

AUTHORITY TO RELEASE SECURITIES

We, the undersigned Board of County Commissioners of Tulsa County, Oklahoma, being in legal meeting convened, have given due consideration to the demand of the 1st Nat'l. Bank of Broken Arrow, Oklahoma, and authorized depository of said County, and the verification of the accounts of said County with said depository Bank as made by the County Treasurer herein, and we find such withdrawal will leave the accounts of the County adequately secured within the sum of \$10,000.00; and therefore we do hereby direct and command that the specific securities identified by the within and foregoing detailed list in the aggregate sum of \$500.00 be released by the County Treasurer and the Custodian of said Securities to the Owner Bank herein or on his order, immediately and without delay.
