Motion by Commissioner Gray, seconded by Commissioner Morley, that the following Resolution be adopted. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF
TULSA COUNTY, OKLAHOMA.

WHEREAS, the certificate of the County Assessor to the Excise Board of Tulsa County shows the total amount of Intangible Tax to be \$389,246.88 for 1942, one half of which when collected will be apportioned to the General Fund of Tulsa County in the amount of \$194,623.44.

WHEREAS, the estimate of the Board of County Commissioners of Tulsa County, Oklahoma, of Intangible Tax Collections for the fiscal year 1942-43 was \$185,677.75 based upon 90% of the collections from the same source for the fiscal year 1941-42 in the amount of \$206,308.61.

WHEREAS, 90% of the amount of Intangible Tax on the rolls in the amount of \$175,161.10 is less than 90% of the collections from said source for the fiscal year 1941-42 in the amount of \$10,516.65.

WHEREAS, \$3,600.00 or 90% of last year's apportionment of collections from rental or lease of county property is not a probable source of collection for the fiscal year 1942-43.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Tulsa County, Oklahoma, in open session this the 24th day of August, 1942, that it is deemed necessary to make the estimate of Intangible Tax for the fiscal year 1942-43 in the amount of \$175,161.10, and

BE IT FURTHER RESOLVED that the estimate of income from rental or lease of County property in the amount of \$3,600.00 be stricken entirely, and

BE IT FURTHER RESOLVED that the County Clerk transmit a copy of this Resolution to the County Excise Board and that the County Excise Board is hereby requested, authorized and empowered to make said reductions in sources of estimated income in compliance with this resolution when approving the budget appropriations and fixing the rate of levy for Tulsa County.
