

is hereby instructed to notify each and every person entitled to compensation for right of way and damages to present his claim in accordance with the Viewer's and Engineer's report as confirmed by the Board of County Commissioners to the County Clerk for payment thereof, and show ownership of land, and upon approval of such claim by the Board of County Commissioners, warrants in payment thereof shall be drawn upon the funds derived from the sale of bonds authorized to be issued and delivered for and on behalf of said Drainage District. Passed and approved this the 28th. day of December, 1922. All members of the Board voting "Aye", the motion was by the Chairman declared carried.

Motion was made by F.M. Wooden, seconded by Ira Short, that the County Clerk of Tulsa County shall cause said certified copies of Judgment and Decree and Journal Entry of Judgment to be spread of record upon the records of said Board; that Bonds of said Park View Drainage District No. 2, Tulsa County, Oklahoma in the sum of \$2,011.86, being the amount of the benefits assessed and confirmed by said Board against the property of the Missouri, Kansas and Texas Railway Company, and its Receiver, shall not be executed or issued; that said County Clerk is hereby directed to make the various entries upon the various records in his official possession as called for and required by said Judgment and Decree and Journal Entry of Judgment as required by law; that said Board of County Commissioners hereby adopts said Judgment and Decree and Journal Entry of Judgment in all things as the orders of this Board and hereby repeals all orders and resolutions in conflict therewith including its Resolution adopted March 20, 1922, entitled: "A Resolution approving the Amended Specifications, Form of Contract, Contract Bond and Proposal Sheet for the doing of all the necessary work in constructing the drainage ditch in Park View Drainage District No. 2, Tulsa County, Oklahoma, and also approving amended specifications, form of contract, contract bond and proposal sheet for the construction of the bridges therein, and all other work pertaining thereto; repealing all resolutions in conflict therewith; and declaring an emergency," in so far as it relates to the specifications, form of contract, contract Bond and proposal sheet for the construction of a bridge in said Drainage District, and also including its order of March 20, 1922, entitled: An order declaring it necessary for the public health, convenience and welfare that there be constructed a bridge over the ditch to be constructed in Park View Drainage District No. 2, Tulsa County, Oklahoma, Said Bridge to be constructed by the Missouri, Kansas and Texas Railway Company upon its right of way."

That by reason of said District being in need of proper drainage it is hereby declared necessary for the preservation of the public health, peace and safety that said ditch be constructed without delay and to that end that this resolution and order become operative immediately; Wherefore, an emergency is hereby declared to exist and this resolution will be in force and effect immediately from and after its passage and approval.

Passed and approved this the 28th. day of December, 1922.

The above motion receiving the affirmative vote of all members present, was by the Chairman declared carried.

Upon motion duly made by Commissioner Wooden, seconded by Commissioner Ira Short, Board was ordered Adjourned until Saturday, December 30th. 1922, at the hour of 10:00 o'clock A.M.
