

R E S O L U T I O N

WHEREAS, since the paving of said alley many of the adjoining buildings have been equipped with large pipes carrying the overflow from the roofs into said alley and causing an excessive flow of water which does not rapidly drain.

THEREFORE, BE IT RESOLVED, By the Board of County Commissioners of Tulsa County that the Commissioners of the City of Tulsa be, and they are hereby respectfully requested to, as an emergency measure to take the necessary steps to correct this condition in order that the said ally will be passable before the winter season begins.
