

Motion made by Commissioner Greer, seconded by Commissioner Gray, that the Contract between Tulsa County and the Midland Valley Railroad Company, dated February 14, 1927, Misc. No. 22056, be and the same is hereby cancelled; as in the opinion of the County Attorney's office, said contract is not binding upon Tulsa County. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Greer, seconded by Commissioner Bailey, that the resignation of J. A. Burton, employee in the County Highway Department, effective as of August 15, 1946, be and the same is hereby accepted. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Gray, seconded by Commissioner Bailey, that the bids received on Project I-d for the improvement of 166th St. North & 116th East Ave., from U.S. 75 and 166th North to U. S. 75 and 116th East Ave.. a distance of 4.039 miles - one bid from Standard Paving Company for a total amount of \$46,796.12, together with their bid check for \$2150.00, and one from Layman & Co., for a total amount of \$44,566.12, together with their bid check for \$2125.00, be and the same are hereby turned over to the County Engineer for compilation and report. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Receipt No. 25517 from the County Treasurer, dated August 3, 1946, covering a deposit of \$5,212.00 made by Commissioner Gray, State Election Check No. 121733 for the Primary Election held on July 2, 1946, was ordered filed.

Motion made by Commissioner Greer, that Claim #377458 in the amount of \$11,477.13 payable to Fate Engineering Company, for professional services in the preparation of construction plans and specifications for the construction of a Bridge across the Arkansas River, at Jenks, Oklahoma; and which Claim was assigned to S. D. Kutch by C. C. Pate of the Page Engineering Company on July 18, 1946, be paid. Upon the recommendation of the County Attorney, the motion was seconded by Commissioner Bailey. Upon roll call, all members voted as follows: Commissioner Gray, No; Commissioner Greer, Yes; Commissioner Bailey, Yes; Motion carried.

Motion made by Commissioner Greer, seconded by Commissioner Bailey, that the renewal of lease contracts with the Herd Equipment Company, covering the leasing of one Mod. MHP-72 Seaman Pulvi Mixer, motor Driven - complete with Motor & Rotor for Mixing Oil Mat Roads; one 1000 Gal Med A-Gunnison Asphalt Distributor, complete with spray bars, swing bars and all other standard equipment; One New Studebaker Truck 2½ ton 6x6 space; one #10-35 Special Lessman Loader with one Bulldozer attachment complete for same; (Lease contracts to run to June 30, 1947) be and the same are hereby approved. Upon roll call, all member voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Bailey, seconded by Commissioner Greer, that the Lease Contract between the Clarence L. Boyd Company and the Board of County Commissioners, covering the rental of one Model "A" International Tractor complete with attachments and #18 Highway Mower - Serial No. IAA-159643, at a rental rate of \$125.00 monthly from August 1, 1946 to February 1, 1947, be and the same is hereby approved, and the Chairman of the Board be and hereby is authorized to sign same.
