Motion made by Commissioner Hardesty, seconded by Commissioner Bailey, and unanimously carried, that the following Resolution be and the same is hereby adopted, to-wit:

R E S O L U T I O N

WHEREAS, in the Court of Common Pleas of Tulsa County, Oklahoma, in criminal case number 56,415, Melvin Williams was charged with the commission of the crime of Unlawfully Leaving the Scene of an Accident, and upon his arraignment was released on a bail bond in the sum of \$250.00, which bail bond was signed by the defendant Melvin Williams, as principal, and Chris Garvis and Toby Williams, as sureties, which bail bond was ordered forfeited by the Court on October 26, 1949, when said defendant, Williams, failed to appear for trial; and

WHEREAS, suit was instituted against defendant Williams, and said sureties, in the Court of Common Pleas, Civil Case No. 33,978, for judgment on said bail bond, and subsequent thereto one of said sureties, Chris Garvis, has made an offer to settle said suit and bond forfeiture for \$165.00, plus the court costs in Civil Case No. 33,978, and upon recommendation of the County Attorney the Board finds that said offer should be accepted.

BE IT THEREFORE, RESOLVED that Elmer W. Adams, County Attorney, is hereby authorized to accept the sum of \$165.00, in full settlement of the claim against the defendant Chris Garvis, growing out of the forfeiture of said bail bond, and to deduct therefrom his statutory fee of said \$165.00, or the sum of \$41.25, and to pay the balance into the office of the Clerk of the Court of Common Pleas of Tulsa County, Oklahoma.

R E S O L U T I O N

WHEREAS, there has been established a County Law Library, as provided by law, with room and facilities therefor provided in the Court House; and

WHEREAS, it appears to the best interest of the county that certain law books heretofore purchased by the county for the County Attorney's office, be transferred from that office to the County Library for general use therein; and

WHEREAS, the County Attorney is agreeable to such transfer;

NOW, THEREFORE, BE IT RESOLVED that the County Attorney be, and he is hereby authorized and empowered to loan to the Tulsa County Law Library and its Board of Trustees, such law books as he deems advisable for transfer to the said County Library for use so long as it may occupy quarters in the Court House, and subject to recall at any time by the County Attorney, or the Board of County Commissioners, and for the loan of which the County Attorney shall take an appropriate receipt.
