

Motion made by Commissioner Couch, seconded by Commissioner Bailey, and unanimously carried, that the County Engineer and County Attorney be instructed to do all things necessary, prerequisite and preliminary to the opening, laying out and constructing of a road to be located:

Beginning approximately .75 of a mile West of the Northeast corner of Section 17, Township 19 North, Range 12 East, in Tulsa County, thence West $1\frac{1}{4}$ miles along the Southside of the Arkansas River, completing the highway from 21st Street to U. S. 64 Highway at the Sand Springs bridge,

and the procuring of right-of-way and easements therefor.

Motion made by Commissioner Hardesty, seconded by Commissioner Bailey, and unanimously carried, that the appointment of Paul W. Brightmire, as a Deputy in the office of the Court Clerk, to act as Minute Clerk in Division No. 1, at a salary of \$200.00 per month, effective as of February 13, 1950, be and the same is hereby approved.

Motion made by Commissioner Hardesty, seconded by Commissioner Bailey, and unanimously carried, that the report prepared by J. A. Caldwell, Certified Public Accountant, of Water Improvement District No. 5, for the period January 1, 1949 to December 31, 1949, be and the same is hereby accepted and filed.
