

EMERGENCY MEETING  
MINUTES  
THURSDAY, FEBRUARY 20, 1986

The Board of County Commissioners for Tulsa County, Oklahoma, met at the hour of 10:00 a.m.  
with the following members present: John Selph, Chairman; Lewis Harris, Member; and Marie Smith,  
Deputy County Clerk. Melvin C. Rice, Member, absent.

John Selph, Chairman, called the emergency meeting to order at 10:00 a.m. and stated that the
