

COMMISSIONERS JOURNAL, TULSA COUNTY, OKLA.

APRIL 29th, 1912.

The Board of County Commissioners met in their rooms at 2:30 P. M., April 29th, 1912.

Upon motion of Mr. Woolly, and seconded by Mr. North, the following Resolution was approved and ordered made a matter of record, all members voting Aye.

In Re Division of Bixby Township,
and Petition to organize a new
Township,

This matter coming on to be heard this 29th day of April, 1912, on petition of J. H. Anderson, et al, asking that the township of Bixby located in Tulsa County, Oklahoma, be divided according to a map heretofore prepared and submitted, and marked for identification, "Exhibit A", wherein the said Bixby Township is divided into two townships, hereafter to be known as Bixby Township, and Glenpool Township. Present, J. H. Anderson, et al, from the town of Glenpool, in person, and by attorneys, Flowers Nelson, and Chas. Steele, of the firm of Lydecker & Steele, and Ed Baker for the old township of Bixby, and others in person and by attorney, Luther James, and the Board of County Commissioners, after hearing the evidence and argument of counsel, resolve, upon motion of Mr. ~~Woolly~~ Woolly, duly seconded by Mr. North, and carried by a unanimous vote, it is resolved as follows:

That the township of Bixby, Tulsa County, Oklahoma, be, and the same is hereby divided into two townships, to be known as Bixby Township, and Glenpool Township; that the said Glenpool Township shall contain the following territory, to-wit: That part of the old township of Bixby described as follows, to-wit: Sections 5, 6, 7, 8, 18, 19, 20, 29, 30, 31, and 32, in Township 17 North, Range 13 East, and Sections 5, 6, 7, 8, 17, 18, in Township 16 North, Range 13 East, and Sections 1, 2, 3, 10, 11, 12, 13, 14, 15, 22, 23, 24, 25, 26, 27, 34, 35, 36, in Township 17 North, Range 12 East, and Sections 1, 2, 3, 10, 11, 12, 13, 14, 15, in Township 16 North, Range 12 East, all in Tulsa County, State of Oklahoma. And that the Bixby Township hereafter shall contain all the remaining territory of the old township of Bixby, Tulsa County, Oklahoma.

That the levy heretofore made for the township of Bixby shall be, and the same is hereby ordered used for the purpose of paying all existing indebtedness of said old township of Bixby; and the County Treasurer of Tulsa County is hereby ordered to pay all funds of the 1911 levy to the Township Treasurer of the old Bixby Township; and it is ordered that the new Township of Glenpool shall exist from and after the signing of this Order, but that no temporary officers shall be appointed prior to the first day of July, 1912.
