

MONDAY, MARCH 1, 1948

Pursuant to recess heretofore taken, the Board of County Commissioners met at the hour of 10:00 O'clock A. M., with all members present: Roy Evans, Chairman; Claude W. Bailey and John Couch, Members. William P. Gable, Jr., County Clerk.

Roy Evans, Chairman, presiding, the following official business was transacted:

Motion made by Commissioner Bailey, seconded by Commissioner Couch, that the action of the Board, of January 22, 1948, authorizing the chairman to execute a contract with the Department of Highways of the State of Oklahoma, for the construction of a bridge over Haikey Creek and a bridge over Bird Creek, in Tulsa County, Oklahoma; and for the deposit of funds from the County Highway Bond Fund, in the amount of \$54,520.00, be, and the same is hereby rescinded, and that in lieu thereof, the chairman be, and he is hereby, authorized to execute a contract with the Department of Highways of the State of Oklahoma, pursuant to House Bill No. 225 of the 1947 Legislature, providing for the deposit of funds from the County Highway Bond Fund, in the amount of \$30,000.00, for the construction of a bridge over Haikey Creek, between Sections 7 and 8, Township 17 North, Range 14 East, two and one-half miles Northeast of Bixby, in Tulsa County, Oklahoma; and a similar contract, providing for a deposit of funds from the County Highway Bond Fund, in the amount of \$86,000.00, for the construction of a bridge over Bird Creek, between Sections 18 and 19, Township 21 North, Range 13 East, one and one-half miles East of Sperry, in Tulsa County, Oklahoma.

AND FURTHER, That the chairman be authorized to deposit with the Department of Highways of the State of Oklahoma, county warrants for \$54,520.00 and \$61,480.00 respectively, heretofore authorized and issued against said bond fund, the issuance of which is hereby ratified; said two warrants, aggregating \$116,000.00 to be deposited with the Department of Highways of the State of Oklahoma, pursuant to said contracts and pursuant to the provisions of said House Bill 225 of the 1947 Legislature, and also pursuant to Operational Memorandum No. 15 of the Department of Highways, dated June 17, 1947, to which reference is hereby made.

All members voting in the affirmative, said motion was by the chairman declared carried.

Motion made by Commissioner Bailey, seconded by Commissioner Couch, and unanimously carried, that a County Deed be issued to Viola Reynolds, covering Lot 1, Block 12, Greenwood Addition to the City of Tulsa, Oklahoma, for the purpose of replacing County Commissioners Resale Tax Deed which was issued by the Chairman of the Board of Tulsa County Commissioners December 28, 1948, and which has been lost or destroyed, and has never been filed of record in the office of the Registrar of Deeds of Tulsa County.

Motion made by Commissioner Couch, seconded by Commissioner Bailey, and unanimously carried, that the appointment of Mrs. Anna Holmes, Deputy in the Office of County Treasurer, at a salary of \$185.00 per month, effective March 1, 1948, be and the same is hereby approved.
