WHEREAS, Tulsa County owns a Galion Master Diesel Motor Grader, Serial # PDGC 539, Motor #19120-a, and a Caterpillar # 44 Pull Type Grader Serial # 4A1095, and

WHEREAS, Said Galion Master Diesel Motor Grader, and Caterpillar # 44 Pull Type Grader being in a state of bad repair, and not generally serviceable for the uses, and purposes of the Highway Department, to which said Galion Master Diesel Motor Grader, and Caterpillar # 44 Pull Type Grader belongs, and was purchased, and paid for from County Highway Funds; and,

WHEREAS, The Highway Department is in need of a Motor Grader, and has found that a trade or exchange can be made with Herd Equipment Company for a new Motor Grader # 102 Galion Tandem Drive Diesel Motor Grader, Serial # M.D. 8642 Motor # UDF 21163-6-47-B, in exchange for the Galion Master Diesel Motor Grader, and Caterpillar # 44 Pull Type Grader, and a further consideration of payment by Tulsa County to the Herd Equipment Company the sum of Five Thousand One Hundred Ninety Eight Dollars and Fifty Cents (\$5198.50).

NOW, THEREFORE BE IT RESOLVED, That the Chairman of the Board of County Commissioners be authorized to transfer title to the aforesaid Galion Master Diesel Motor Grader, and Caterpillar # 44 Pull Type Grader, and deliver same to the Herd Equipment Company in exchange for the said Motor Grader # 102 Galion Tandem Drive Diesel when accompanied by a proper transfer of title to Tulsa County, and that the County Highway Department be authorized to draw a Claim to the Herd Equipment Company in the sum of Five Thousand One Hundred Ninety Eight Dollars and Fifty Cents (\$5198.50), payable from Account No. 6-B, designated as "Highway Equipment" of the Tulsa County Highway Department GENERAL Fund.
