This cause coming on for hearing on this 7th day of May, 1912, before the Honorable Board of County Commissioners of Tulsa County, Oklahoma, at a regular meeting of said Board, and said Board having heard the testimony and being advised in the premises:

IT IS ORDERED, CONSIDERED AND ADJUDGED that the original Drainage District heretofore proposed in said matter be and the same is hereby modified and altered, in this:

That the premises hereinafter described are hereby excluded from said Drainage District, and form no portion thereof, and said Drainage District as now constituted does not include the same, the said lands so excluded being described as follows:

The West Half of the Southeast Quarter, being Lots Five and Eight, and the West Half of the West Half of the Northeast Quarter of the Southeast Quarter of Section Thirty-six, Township Nineteen (19) North, Range Twelve (12) East.

And the lands of Lela M. Orcutt, S. A. Orcutt, guardian, being the Southeast Quarter of the Southeast Quarter, and the East Half of the Northeast Quarter of the Southeast Quarter, and the East Half of the West Half of the Southeast Quarter of Section Thirty-six (36), Township Nineteen (19) North, Range Twelve (12) East, all in Tulsa County, Oklahoma.
