Said bond being in the amount of Five Thousand (\$5,000.00) Dollars, issued by Fidelity and Deposit Company of Maryland, and after due consideration a motion was made by F.M.Wooden, seconded by Ira Short, that the said Bond be and the same is hereby approved. All members of the Commission voting in the affirmative, the motion was duly carried.

The Bond of James T.Whiteley, elected County Assessor, was presented. Said Bond being in the amount of Five Thousand(\$ 5,000.00) Dollars, issued by Fidelity and Deposit Company of Maryland, Upon motion made by F.M.Wooden, seconded by Ira Short, said Bond is hereby approved.

The Bond of O.G.Weaver, elected County Clerk, was next to be presented, in the amount of Five Thousand (\$5,000.00) Dollars issued by Fidelity and Deposit Company of Maryland. Upon motion of F.M.Wooden, seconded by Ira Short, the Bond was approved and ordered filed in the office of the County Treasurer. Motion carried.

The Bond of Jno. M. Goldesberry, elected County Attorney, was presented, same being in the amount of One Thousand (\$1,000.00) Dollars, and after due consideration and upon motion made by F.M.Wooden, seconded by Ira Short, same was approved and ordered filed. Motion carried.

Motion was made by Geo.E.Gilmore, seconded by F.M.Wooden, that the above named officers having been duly elected, for the term beginning January 1st, 1923, having qualified in the manner and form as by law provided, and having filed an oath of office, they are hereby qualified and the retiring officers are hereby authorized to deliver their records to the above named officers. The following vote was had on the above motion: Geo.E.Gilmore, Yes, F.M.Wooden, Yes, and Ira Short, Yes. Motion was declared carried.

Motion was made by F.M.Wooden, that the appointees, as named by County Attorney Jno.M.Goldesberry, be and the same are hereby approved. Motion was seconded by Ira Short and the vote cast was as follows: Geo.E.Gilmore, Yes, F.M.Wooden, Yes, and Ira Short, Yes. Motion carried.

Motion was made by F.M.Wooden, seconded by Ira Short, that the appointees as made by the Sheriff, R.D.Sanford, be and the same are hereby approved. Motion carried. An amendment was offered in connection with the above motion, in which an objection was offered to the appointment of one John Smitherman, but after an investigation was made objection was withdrawn and appointment approved.

Motion was made by Ira Short, seconded by F.M.Wooden, that the appointees as listed by Court Clerk, Hal Turner, be and the same are hereby approved. The motion received the unanimous vote of the Commission.

Motion was made by F.M.Wooden, that all Bonds of Justices of Peace and Constables be turned over the County Clerk for investigation of Sureties and to make report to Commissioners at the earliest possible date. All members voting in the affirmative, motion was declared carried.

Motion was made by Ira Short, who moved its adoption, and the motion to adopt was seconded by F.M.Wooden,
