Pursuant to recess heretofore taken, the Board of County Commissioners reconvened at the hour of 2:00 o'clock P. M. with all members present and presiding as before.

Motion made by Commissioner Greer, seconded by Commissioner Gray, that Miss Lucille Dohogne be appointed Assistant Home Demonstration Agent, replacing Geraldine Hedges who has been transferred to another County, at the same salary paid Miss Hedges, and effective August 15, 1946. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Greer, seconded by Commissioner Gray, that the following estimates be and the same are hereby approved: First estimate submitted by Layman and Company on Project No. 1-A improving 46th St. North from Cincinnati Avenue amounting to \$25,503.38 to Lewis Avenue; first estimate submitted by Layman and Company on Project No. 3-A improving 21st Street from Yale Avenue to Memorial Drive, amounting to \$23,235.75; first estimate submitted by Standard Paving Company on Project No. 2-B improving Sand Springs Road Bruner Hill to Paving in Place on McKinley Avenue at Sand Springs, amounting to \$33,887.03; first estimate submitted by Layman and Company on Project 1-C improving Cincinnati Avenue from Mohawk Blvd. to 46th Street North, amounting to \$40,236.07 and the Final estimate submitted by Standard Paving Company on Project No. 2-A, improving from North City limits of Sand Springs to Osage County Line (extension of McKinley Ave.) amounting to \$14,234.86. Motion made by Commissioner Greer, seconded by Commissioner Bailey, that the Chairman be and hereby is authorized to execute Quit Claim Deed to O. H. P. Thomas on Lot 26, Block 1, New Tanaha. This deed is given for the purpose of releasing Tax Deed to Tulsa County, recorded in Book 1278, page 456. Said tax deed was issued in error, as all taxes had been paid prior to date of sale.
