Motion by Commissioner Hopkins, seconded by Commissioner Gray, that Ted Moore be placed on the regular road employees payroll at the rate of \$140.00 per month in the capacity of mechanic; also that C. C. Cotton be placed on the regular road employees payroll as truck driver at \$100.00 per month as of October 1st, 1938. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

The following Resolution was introduced by Commissioner Gray, who moved its adoption; said motion being seconded by Commissioner Hopkins. Chairman ordered the Resolution read.

RESOLUTION AUTHORIZING THE PAYMENT OF JUDGMENT
IN CASE NO. 2288 LAW, FEDERAL COURT, NORTHERN
DISTRICT OF OKLAHOMA, OUT OF SINKING FUND TULSA
COUNTY.

WHEREAS, on the 17th day of June, 1937, the United States of America obtained a judgment against Tulsa County in behalf of its Indian Ward, Pansy B. Hawk, which now, with interest computed to this date, that is October 10, 1938, amounts to \$5,732.65, and the costs thereon amount to \$53.90, making a total of \$5,786.55, and

WHEREAS, the funds in the sinking fund of Tulsa County, Oklahoma, are sufficient to pay interest on bond coupons falling due during this fiscal year, and all prior matured installments on principal and interest on bonded indebtedness, and all prior charges against the sinking fund, and in addition thereto there is an unencumbered cash balance in said sinking fund sufficient to pay said judgment, and

WHEREAS, we consider it to be to the best interests of Tulsa County that said judgment be purchased in order to stop the interest thereon;

NOW, THEREFORE, BE IT RESOLVED, that the County Treasurer of Tulsa County, Oklahoma, is hereby authorized and directed to pay said judgment out of the sinking fund of Tulsa County, Oklahoma, and that it pay the said judgment of \$5,732.65 and the instrument of payment be to the Treasurer of the United States of America, and that \$53.90 be paid to H. P. Warfield, Clerk of the United States District Court for the Northern District of Oklahoma, in payment of the costs.
