The following motion was introduced by Mr. North, and duly seconded by Ed W Hedgecock, and the Chairman ordered the Resolution read:

## R E S O L U T I O N

WHEREAS, Tulsa County has at the present time Drainage Districts commonly known and designated as Frye Drainage District, Perryman Drainage District and Parkview Drainage District.

AND, WHEREAS, under the drainage laws of the State of Oklahoma, the Drainage Commissioner of each district is charged with the inspection of the drains and improvements therein with the view of keeping the same in repair and cleaned out, and

WHEREAS, it is the duty of the Drainage Commissioner of said District under Sec. 6077 C O S of 1921, to make and file estimates and assessments for repair or cleaning such District, to this Board, and

WHEREAS, under said Section, the work of repairing or cleaning out the drain shall be advertised and let under contract and the payment for such work to be made out of the maintenance assessment upon the certificate of the Drainage Commissioner, and

Whereas, under the law, the control and supervision of such Drainage District are in the Board of County Commissioners of this County.

NOW, THEREFORE, BE IT RESOLVES, That for the purpose of protecting the interests of the land owners upon whom the maintenance assessments fall each year that Ben Smedley be, and he is hereby appointed as an Inspector over all of said Drainage Districts, acting for and on behalf of the Board, and that no work shall be performed or paid for in any of such Drainage Districts or no contract made for repairs, materials or supplies therein, by any of the Drainage Commissioners in any of said Districts without first obtaining the consent and approval of the said Inspector, and that all claims for expenditures upon said drainage district shall be approved by the respective drainage commissioners in each district and certified to by the respective Inspector, Ben Smedley before allowance by this Board.

AND, BE IT FURTHER RESOLVED, That the only necessary and emergency repair work and of a limited nature shall be performed by said Drainage Commissioners in said respective Districts. That the work of repairing and cleaning of the ditches shall be let under contract in the manner and provided by Sec. C O S 6077 1921.

## - R E S O L U T I O N -

The following Resolution was introduced by Mr. North, and duly seconded by Mr. Hedgecock, and upon roll call determined that same was carried unanimously.

WHEREAS, it is considered for the best interests of Tulsa County to extend the Contract with Roy Tanner Paving Company to cover additional yardage of paving at Red Fork, and

WHEREAS, it is mutually agreed to by and between the said Roy Tanner Paving Company and the Board of County Commissioners of Tulsa County, to extend the said contract at the same prices as bid in the original proposal, and all the conditions of the original contract to govern in the extension.

NOW, THEREFORE, BE IT RESOLVED, That Contract No. 170 "A" be and the same is hereby extended to cover the additional yardage to the extent of \$3,956.30.

## - R E S O L U T I O N -

The following Resolution was introduced by Mr. North, who moved its adoption and the motion was seconded by Mr. Hedgecock.

WHEREAS, it is necessary that Frye Drainage District No 1, and Perryman Drainage District No.2, in Tulsa County, be cleaned and repaired, and

WHEREAS, this Board has made an assessment for the fiscal year ending June 30th. 1928, against the lands embraced within said Districts for the purpose of cleaning and repairing said Drainage Ditches.

NOW, THEREFORE, BE IT RESOLVED, That the County Engineer be and he is hereby instructed in connection with the Drainage Commissioner of each of the said districts to make and prepare for each of said districts an estimate, together with the plans and specifications for the repairing and cleaning of the ditches therein, and submit the same to the Board, together with the necessary notices for advertising and letting such work upon contract to the lowest responsible bidder.
