RESOLUTION

BE IT RESOLVED, that the County Treasurer of Tulsa County, be and he is hereby empowered and directed, pursuant to Chapter 66, Article 8, Session Laws, 1931, Page 250, to transfer income and revenue derived during this fiscal year by Tulsa County from gasoline excise Tax and from automobile tax to the amount of Twenty (\$20,000.00) Thousand Dollars to the County Sinking Fund to be used in the payment of interest and principal on bonds heretofore issued by Tulsa County for the construction of hard surfaced roads in said County, said transfers to be made in twelve (12) equal monthly payments of \$1,666.66 each, except the last payment to be \$1,666.69.
