MONDAY, AUGUST 26, 1946

Pursuant to recess heretofore taken, the Board of County Commissioners reconvened at the hour of 10:00 o'clock a. m. with the following members present: J. B. Gray, Chairman; Claude W. Bailey, Member. Andy Stokes, County Clerk. Curtis Greer, Member, absent.

J. B. Gray, Chairman presiding, the following business was transacted.

Motion made by Commissioner Gray, seconded by Commissioner Bailey, that the Supplemental Election payroll in the amount of \$3.00 covering County Expense Claim to Mrs. Bertha McKee, worker in the Primary Election, July 2, 1946; and whose name was left off the payroll thru error, be and the same is hereby approved. Upon roll call, both members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Mr. Gray, seconded by Commissioner Bailey, that the application and order to strike taxes filed by the City of Tulsa for the years 1931, 1932, 1933, 1939, 1940 and 1941 covering West 134' Block 1, Boulder Park Addition be and the same are hereby stricken from the rolls, upon the approval of Dan Rowe, County Assessor. The Chairman is hereby authorized to sign same. Upon roll call, both members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Gray, seconded by Commissioner Bailey, that upon the recommendation of Dan Rowe, County Assessor, the Application and Order filed by the City of Tulsa, to strike taxes for the years from 1930 to 1938, inclusive; and the years 1942, 1943 and 1944, on the South 150' of Block 4, Boulder Park Addition, be and the same is hereby approved and the Chairman is hereby authorized to sign the order striking same. Upon roll call, both members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Gray, seconded by Commissioner Bailey, that upon the recommendation of Dan Rowe, County Assessor, the following affidavits of erroneous assessment be and the same are hereby approved, and the County Clerk is instructed to issue certificates of error covering same. Upon roll call, both members voting in the affirmative, motion was by the Chairman declared carried.

Miss Nowlin to receive same salary as paid Mrs. Sawyer. Upon roll call, both members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Gray, seconded by Commissioner Bailey, that a recess be taken until Monday, September 3, 1946, at the hour of 10:00 o'clock A. M. Motion carried.
