WAIVER AND AGREEMENT

THIS AGREEMENT made and entered into this 28th day of July 1937, by and between Tulsa County, sponsor for W. P. A. Project Number 1-4735, covering: Bring Road to standard grade and drainage, and the Works Progress Administration for Oklahoma, herein represented by Ron Stephens, State Administrator, WITNESSETH:

WHEREAS, the sponsor is desirous of obtaining assistance in the construction of its W. P. A. Project Number 1-4733, funds from the Works Progress Administration for Oklahoma, and

WHEREAS, reductions may be made from time to time both in allowable quota of workers and funds for other than labor items, and,

WHEREAS, it is necessary that the Work Program be operated in accordance with such regulations as may be orimulgated from time to time.

NOW THEREFORE, be it understood and agreed between the sponsors and the Works Progress Administration for Oklahoma that the approval and initiation of this Project does not create an obligation on the part of the Works Progress Administration for Oklahoma to complete the project if such reductions are made. In the event of such reductions, the sponsor agrees either to accept the work which has been done at that time and take over the project, carrying the same to completion, or to such an extent that the project will be usable and will not be left in an unsightly or discreditable condition and to conform to such new regulations as may be established from time to time.

In compliance with Sec. 1, Title 1 Emergency Relief Appropriation Act of 1937, the sponsor, by these presents, agrees to finance such part of the entire cost of the said project as is not to be supplied from Federal funds; and the sponsor hereby assumes full responsibility for all of the items of materials, equipment, labor, etc. to which they have agreed in the approved 301.

It is further understood and agreed that neither the approval of this project at this time, nor its initiation creates on the part of the Federal Government any commitment, obligation or implied contract for its completion under the conditions which are applicable at the time of its approval.
