

## O R D E R.

WHEREAS, The Treasurer of Tulsa County, Oklahoma, has filed and presented to the Board of County Commissioners of the County of Tulsa, State of Oklahoma, an application for the issuance to HUGH J EVANS the record owner of the lot hereinafter described, of a deed conveying to him, for a consideration of Two Hundred Dollars (\$200.00) the following described Lot, to-wit:
