ORDER

WHEREAS, the Treasurer of Tulsa County, Oklahoma, has filed and presented to the Board of County Commissioners of the County of Tulsa, State of Oklahoma, an application for the issuance to Ben F. Curtis of a deed conveying to him for a consideration of Two Hundred and No/100 dollars (\$ 200.00 ) the following described lot:
