## MAY 27th, 19P2.

The Board of County Commissioners met in their rooms in the Court House at 2 P. M., Monday, May 27th, 1912. All members present.

Upon motion the following Order was approved and made a matter of record:

> IN THE MATTER OF THE INCORPORATION OF SAND SPRINGS. IN TULSE COUNTY, OKLAHOMA.

## ORDER

And Now, on this 27th day of May, 1912, the above entitled cause coming on for hearing, and the applicants for the indorporation of the following described lands as an incorporated town under the name of Sand Springs, appearing by their counsel, Rice and Lyons, and the statement of the inspectors heretofore appointed in this case having been presented to the Board of County Commissioners, the Commissioners find

First, That on the 22nd day of May, 1912, there was filed and returned to the Board of County Commissioners a statement, verified by the affidavit of F. E. Gray, T. W. Spillman and W. E. Justice, to the effect that on the 21st day of May, 1912, the said affiants, together, acted as inspectors of an election held to determine whether the following described kand property, to-wit:

The Southeast Quarter  $(\frac{1}{4})$  of the Northwest Quarter  $(\frac{1}{4})$ , the Southwest Quarter  $(\frac{1}{4})$  of the Northeast Quarter  $(\frac{1}{4})$ , the West Half  $(\frac{1}{2})$  of the Southeast Quarter (1) except the M.K.& T.R.R.Co's right of way: the East Half  $(\frac{1}{2})$  of the Southwest Quarter  $(\frac{1}{4})$  except the M.K.& T.R.R.Co's right of way; also a strip of ground One Hundred Twenty (120) feet wide off the South side of the Northeast Quarter (1) of the Northwest Quarter (‡), and a strip of ground One Hundred Twenty (120) feet wide off the South side of the Northwest Quarter  $(\frac{1}{4})$  of the Northeast Quarter  $(\frac{1}{4})$ ; all of the above described property being in Section Eleven (11), Township Nineteen (19) North, Range Eleven (11) East, and containing 241.17 acres, exclusive of right of way of M. K. & T. Ry. Co.,

should be an incorporated town, and that at said election, ballots were cast having thereon the words "For Incorporation," Yes" and "For Incorporation, No,"; that at said election forty-one (41) ballots were cast, and of said ballots cast, a majority of the ballots cast were "For Incorporation. Yes", and that a true and correct statement of the vote cast was

> " ForIncorporation, Yes" " For Incorporation, No"

Forty-one votes. None

That said election was held in the Kingsbury Building, the place named by the Bord of County Commissioners of Tulsa County, Oklahoma, for the holding of said election, and that said polls at said place were opened at nine o'clock in the fore-noon of the said 21st day of May, 1912, and were kept open until four o'clock in the afternoon of said day.

Second. That on the 22nd day of May, 1912, there was filed in the office of the Board of County Commissioners, the affidavit of Joseph J. Maroney to the effect that on the 7th day of May, 1912, affiant posted ten copies of the notice of election hereto attached, marked Exhibit "A" and made a part of this finding, in ten of the most public places within the proposed town-site above described, and that on said 22nd day of May, 1912, there was filed in the office of the Board of County Commissioners, the affidavit of William Stryker, Editor and Publisher of the Daily Democrat, to the effect that the notice hereto attached and marked Exhibit "A" amd made a part of this finding as aforesaid was published for ten consecutive issues in said newspaper, the first publication of said notice being the issue thereof appearing on the ninth day of May, 1912, and the last publication of said notice in said newspaper being the issue thereof appearing on the 20th day of May, 1912.

Third. The Board of County Commissioners, having examined the affidavits offered, heard the testimony, and statement of counsel, and being fully advised in the premises, are satisfied of the legality of the said election.

Fourth. The Board of County Commissioners, having examined the proceedings heretofore had looking to the incorporation of the aforedescribed lands, and being fully advised in the premises, find such proceedings complete and sufficient.

NOW, THEREFORE, IT IS ORDERED that said townsite be and hereby is a duly incorporated town under the laws of the State of Oklahoma by the name and style of SAND SPRINGS.
