

TUESDAY, MARCH 23, 1948

Pursuant to recess heretofore taken, the Board of County Commissioners met at the hour of 2:00 O'clock P. M., with the following members present: Roy Evans, Chairman; John Couch and Claude W. Bailey, Members. William P. Gable, Jr., County Clerk.

Roy Evans, Chairman, presiding, the following official business was transacted:

Motion made by Commissioner Evans, seconded by Commissioner Bailey, and unanimously carried, that Estella Bell be, and she is hereby appointed as Janitress at the Tulsa County Medical Clinic, to replace Frankie Starr, effective March 22, 1948.

Motion made by Commissioner Bailey, seconded by Commissioner Couch, and unanimously carried, that M. E. Gibson be, and he is hereby approved as Deputy Sheriff, effective March 20, 1948, at a salary of \$200.00 per month, vacancy created by the leave of absence of Tommy Warren.

Motion made by Commissioner Bailey, seconded by Commissioner Couch, and unanimously carried, that the County Highway Cash Fund Estimate of Needs and Request for Appropriation for the County Highway Cash Fund, in the amount of \$33,329.55, and the Cash Fund Estimate of Needs and Request for Appropriation for the County Highway Restricted Cash Fund, in the amount of \$4,795.76, be and the same are hereby approved, and the Chairman is authorized to sign same and submit it to the Excise Board for their consideration.

Motion made by Commissioner Bailey, seconded by Commissioner Evans, and unanimously carried, that the following Resolution be adopted:

WHEREAS, The State Highway Commission of the State of Oklahoma has agreed to submit to the Federal Works Agency, Public Roads Administration, a project for the improvement of a bridge over Haikey Creek between Section 7 and 8, Township 17 North, Range 14 East, two and one-half miles North-East of Bixby, Oklahoma with funds apportioned to the State under the Federal Highway Act as amended and supplemented, and

WHEREAS, The County of Tulsa, Oklahoma desires that such improvement be made and does agree to maintain said highway in a manner satisfactory to the State Highway Commissioner of the State of Oklahoma after its improvement, therefore:

BE IT RESOLVED: That the Chairman of the Board of County Commissioners of said County be, and he is hereby authorized and empowered to enter into and execute a contract and agreement with said State Highway Commission carrying out the purposes of this resolution.

Adopted this 23rd day of March, 1948 by the unanimous vote of said Board of County Commissioners.
